



## Community Pharmacy Practice Enactments

In addition to the [Emergency Preparedness Tools](#) that already exist to address any disruptions to patient care, the following enactments by regulatory authorities have been made to help pharmacy professionals address evolving challenges in patient access to health care.

It is important that pharmacy professionals understand these enactments, including what authorized activities are permitted under their scopes of practice, and the terms and conditions that apply.

SCPP works closely with other regulatory partners, the provincial government (Ministry of Health (MoH)) and federal government (Health Canada) to respond to developing events.

**Should conflicting messaging arise, contact the SCPP to confirm which direction prevails for pharmacy professionals.**
